

# Marion Wings & Wheels Inc. 501 c 3

## Vendor Agreement

The parties to this contract are Marion Wings & Wheels Inc. (hereafter "Host") and

\_\_\_\_\_ (hereafter "Vendor").

Whereas, Host's Event, known as Wings & Wheels Fly-In/Cruise-In, occurs at the Marion Municipal Airport, 1530 Pole Lane Road, Marion, Ohio, September 15 & 16, 2018, beginning at 9:00 A.M. and ending at 4:00 P.M., Vendor desires to vend from a food truck /food trailer during the Event, upon the following terms and conditions at the discretion and direction of Host, and

Whereas, Vendor agrees to pay the Host the sum of fifty dollars (\$50.00) and ten percent (10%) of gross sales/receipts . The fifty dollars (\$50.00) is to secure a commitment by Vendor, is non-refundable and is required by April 27, 2018. Prior to leaving the Event ten percent (10%) of gross sales/receipts will be paid to Host.

Now, therefore, the parties agree as follows:

1. Vendor shall have access to the venue 24 hrs. before the Event's commencement or by coordinating with Host for setting up Vendor's station, goods, and other appurtenances necessary and reasonable to vending. And, shall at all times only operate on the specific defined location identified by Host.
2. Vendor **shall not sell water**; only goods or services offered in the course of the Vendor's daily operation of their food truck/food trailer during the Event unless the Vendor receives Host's prior written consent.
3. Vendor's food truck/food trailer shall be clean and orderly and shall comply with all applicable laws and regulations.
4. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
5. No loud music, noise, or sound amplification devices shall be used by the vendor's staff at the location.
6. Vendor shall have access to the location for up to 1.5 hrs. after the Event's conclusion at 4:00 P.M., to dismantle and remove all things brought to the location by the Vendor. Vendor shall leave the location free of trash and substantially in the condition it was before Vendor occupied it.
7. Vendor hereby agrees to indemnify and hold harmless the Host and in addition, the City of Marion, Ohio against any damages or claims that may arise in connection with the Vendor's presence at the Event and Vendor's activities of any kind.
8. Vendor shall be self-contained. No water or electrical utilities are available at this venue.
9. Vendor will honor "Food PASSPORT" when presented by a Pilot for one (1) free lunch Saturday & Sunday
